

NO COMBUSTIBLE MATERIAL WITHIN 6" OF THE TOP OF THE FIREPLACE.

COMBUSTIBLE MATERIAL SHALL NOT BE PLACED DIRECTLY ON THE FACE OF THE FIREPLACE, TOP.

- 2 NO COMBUSTIBLE MATERIAL WITHIN 1" OF THE SIDES AND BACK OF THE FIREPLACE.
 COMBUSTIBLE MATERIAL SHALL NOT BE PLACED DIRECTLY ON THE FACE OF THE FIREPLACE, BACK AND SIDES.
- 3 1" CLEARANCE TO B-VENT MUST BE MAINTAINED.
- 4 GAS LINE PRESSURE: 80,000 BTU MEASURED AT 7.0"/11.0" W.C. REQUIRED. NG/LP POWER REQUIREMENT: 120 VAC, 5 AMP MAX DRAW.
- 5 STEEL 3" SURFACE MAY BE LEFT EXPOSED OR COVERED WITH COMBUSTIBLE FINISHING MATERIAL. FASTENERS SHALL NOT PENETRATE THE 3" SURFACE.




 THERE SHALL BE ACCESS FROM THE INSIDE OF THE FIREPLACE AS WELL.

 FIREPLACE SHALL HAVE LINEAR FLAME DOWN THE LONG AXIS, RIBBON BURNER.
 FIREPLACE SHALL HAVE MEDIA BED LIGHTING.
- 13 INTAKE COLLAR CAN BE ROTATED TO VENT OFF THE SIDE, OR FROM THE BOTTOM OF THE FIREPLACE.


